Frequently Asked Questions

What is your event cancellation policy?

Refunds are granted up to 5 business days in advance, less a \$10 processing fee. Transfer of registration to another person is allowed.

Will NASECA-WI cancel due to inclement weather?

NASECA-WI reserves the right to cancel any event or training due to inclement weather, but cancellations will be avoided if at all possible. NASECA-WI will begin monitoring the weather 24 hours before the event and make the final decision of cancellation as far in advance as possible. NASECA-WI will take the following into consideration when making the decision:

- The Wisconsin Department of Transportation deems the roads within 20 miles of the event venue unsafe for travel or
- The public school systems within 20 miles of the venue close.

Upon cancellation, NASECA-WI will make reasonable efforts to email all participants and post cancellation notices on our website and social media outlets. If NASECA-WI cancels a training in which you are registered, you will be contacted at the email address you provided when registering. It is the responsibility of each registered individual to provide a valid email address. While we understand the cancellation of an event is inconvenient, our main priority is to keep our members and attendees safe. If NASECA-WI cancels the training due to weather or circumstances beyond the control of NASECA-WI, NASECA-WI is not financially responsible for travel or other costs incurred in planning for attendance
